He established the International Military Tribunal for the Far East, with trials set to begin in May 1946 in Tokyo. Based on the precedents set at Nuremberg (see reading, *Establishing the Nuremberg Tribunal* ), the Far East tribunal indicted 28 Japanese military and civilian leaders for war crimes, crimes against peace (which included planning a war of aggression), and crimes against humanity.
